An Important Notice Concerning our Privacy Policy

We provide our Financial Privacy to customers when they conduct business with our company. If we change our privacy policies to permit us to share additional information we have about you, as described below, or to permit disclosures to additional types of parties, you will be notified in advance

Information We Collect

We collect nonpublic personal information about you from the following sources:

- Information we receive from you in applications, forms and other information that you provide to us, whether in writing, in person, by telephone, electronically or by other means. This information may include your name, address, employment information, income and credit references;
- Information about your transactions with us or others. This information may include your account balances, payment history and account usage;
- Information we receive from a consumer-reporting agency. This information may include account information and information about your credit worthiness; and
- Information that we receive from public sources. This information may include real estate records, employment records, telephone numbers, etc.

We restrict access to nonpublic personal information about you to any other party, except those parties we must share your information with in order to get the loan closed, funded and sold or parties with which we are legally allowed to share information with as permitted by law.
